



2025 Spring Immunization Guide

Comprehensive Student Health Services

Overview

As a reminder, Florida Statute 1003.22, Rule 64D-3.046 of the Florida Administrative Code, and school board policy 5320 collectively require that every child entering, attending, or transferring into school in grades kindergarten (KG) through 12 must have a Florida Certificate of Immunization (DH Form 680) indicating the student has met the immunization requirements for the required grade level.

Each October, Florida Statute 1003.22 requires the District to submit an annual immunization report of compliance to the Florida Department of Education.

1. Students entering **Kindergarten Fall 2025** must obtain the 2nd MMR ([Mumps](#), [Measles](#), and [Rubella](#)) and the 2nd [Varicella](#) vaccine.
2. Students entering the **7th grade Fall 2025** must obtain the [Tdap](#) booster ([Tetanus](#) [Diphtheria](#) [Pertussis](#)) vaccine.
3. Students in **ALL grades** with an **expired** immunization status must present a **new** Florida Certificate of Immunization-680 form.

INITIAL HEALTH ENTRY REGISTRATION

- ☐ Students that do not have the medical documentation at the time of registration that meet the criteria listed below have 30-days to bring in the required health records.
- ☐ Refer to School Board Policy 5330 for additional information.

Exceptions: (30-day Exemptions)

- ☐ Displaced Students (Project UP-START)
- ☐ Students in the Unified Children's Court System (Delinquency/Dependent)
- ☐ Children of active military families



Initial School Entry Health Exam (DH-3040)

Must be performed within twelve (12) months by a medical provider.

MUST include a **tuberculosis clinical screening only**.

- ☐ Based on the outcome of the TB questionnaire screening, the medical provider will determine if the student needs the TB test (injection).

A positive (+) screening test will require a follow-up skin test.

The student may enroll **ONLY** with a medical provider's statement that the student is free of communicable tuberculosis and can attend school.

- ☐ Students transferring from within the state of Florida or a student that was previously enrolled in M-DCPS are **NOT** required to be re-examined.

Florida Certification of Immunization (DH-680)

Students enrolling in school for the first time or transferring into:

M-DCPS from out-of-state **MUST** present **one** of the following:

1. Part A- CODE-1

- ☐ **ALL** immunization requirements are met. No additional immunizations are needed at this time.

2. Part B-CODE 2

- ☐ Temporary Medical Exemption, the student must have a **valid** immunization code.

3. Part C-CODE 3

- ☐ Permanent Medical Exemption- child cannot receive one or more vaccines.
- ☐ The medical provider must indicate on the Florida Certificate of Immunization which vaccine the student is medical exempt from receiving.

4. CODE 4

- ☐ Religious Certificate of Immunization (DH-681)
- ☐ Issued **ONLY** by DOH for a child who is not immunized because of his/her family's religious beliefs.

PLEASE NOTE: The Florida Certificate of Immunization **MUST** match the immunization code inputted in DSIS.

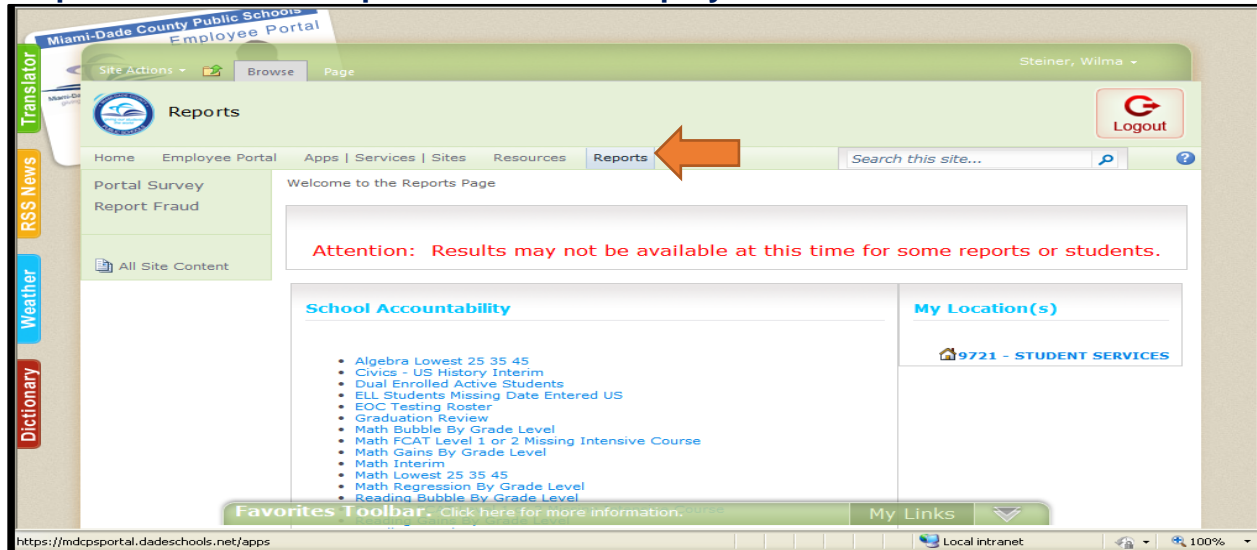

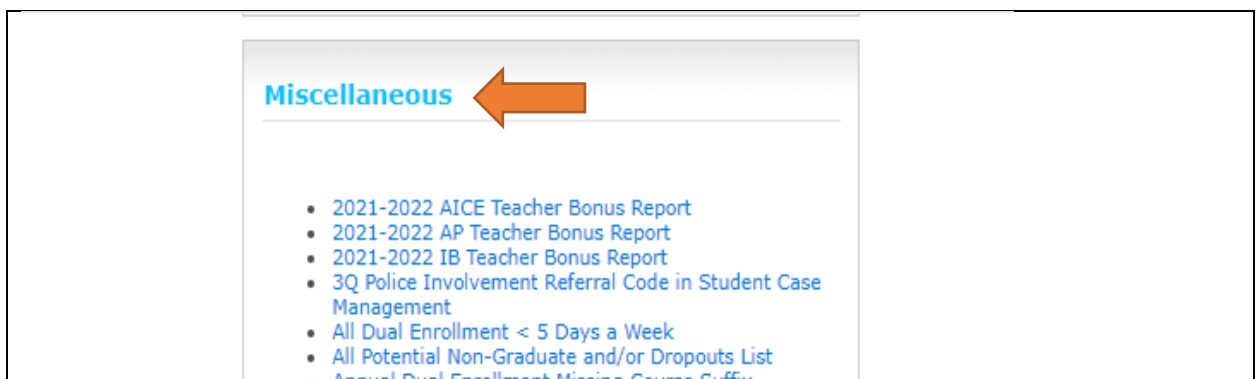
- ☐ Please **share** the weekly briefing and the 2025 Spring Immunization Guide with your school registrar.
- ☐ Ensure that your registrar has access to the school's Immunization Compliance Report.
- ☐ Both the principal and the registrar **must** review the Immunization Compliance Report on a weekly basis, as it provides real-time daily updates.

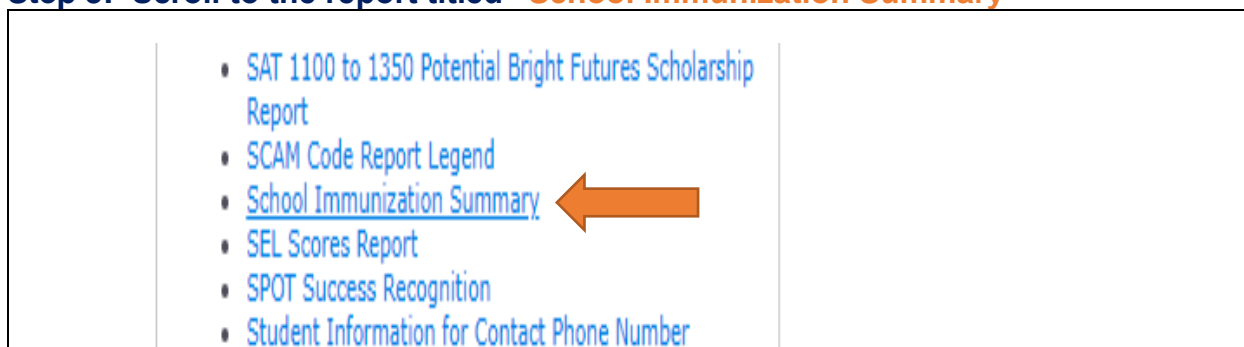
Step 1: Click on the Reports Tab in the Employee Portal



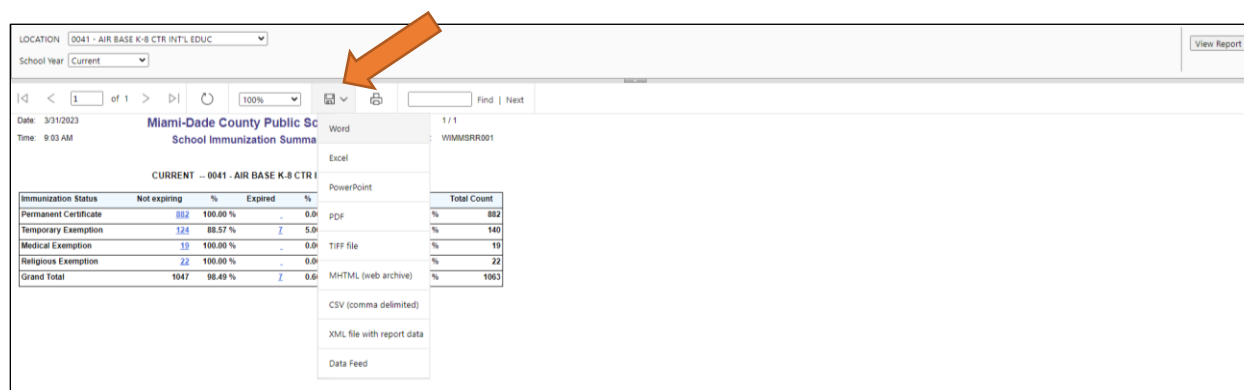
Step 2: Scroll to the Miscellaneous Header

INSTRUCTIONS FOR REGISTRAR

- ☐ Print the following from your school’s immunization compliance report:
 - Students who have an **expired** immunization status
 - Students who have an immunization status that will expire **in 30 days**
 - Students who are futured for **Kindergarten (KG) Fall of 2025**
 - Students who are futured for **7th grade Fall 2025**

- ☐ Students **futured** for grades KG and 7th can be located under the **“Temporary Exemption-Not expiring tab”**

- ☐ Contact the parent/guardian of each student listed on the Immunization Compliance Report to inform them of their child's immunization status.
- ☐ Notify the parent/guardian that a letter regarding their child's immunization status will be sent home.
- ☐ Print the immunization status letter included in the Weekly Briefing.
- ☐ Distribute the letter to the following students:
 - Students who have an **expired** immunization status
 - Students who have an immunization status that will expire **in 30 days**
 - Students who are futured for **Kindergarten (KG) Fall of 2025**
 - Students who are futured for **7th grade Fall 2025**

- ☐ If the registrar or principal needs assistance accessing the Immunization Compliance Report, please contact the Office of District Operations | Comprehensive Student Health Services at (305) 995-4111.
- ☐ The District will be partnering with our school-based partners to offer **FREE** school-age vaccines at select elementary, middle, and K-8 schools.
- ☐ Schools will be selected based on the number of students who **have not** received the required KG and 7th grade-level vaccine Fall 2025.
- ☐ The school-based health provider will coordinate on-site immunization drives directly with selected principals.
- ☐ The school-based provider will provide their consent form to the principal for distribution to students listed on the Immunization Compliance Report.
- ☐ A signed consent form is required for a student to receive the vaccine at school.
- ☐ Parent presence is not required for the student to be vaccinated at the school site.

This is a great opportunity to support students listed on your Immunization Compliance Report with statuses marked as EXPIRED, EXPIRING IN 30 DAYS, or FUTURE for Kindergarten and 7th grade immunizations for Fall 2025.

Parents/guardians can contact their child's medical provider if they have any questions regarding what vaccines their child needs for school.

Miami-Dade County Public Schools wants to notify you that your child's immunization record indicates they are due for a school-age vaccine.

According to Florida's school immunization law (**1003.25-Florida Statutes**), all students attending school must have proper immunization documentation.

It is imperative that you take your child to their medical provider or schedule an appointment with the Florida Department of Health in Miami-Dade County's immunization program by calling 786-845-0550. You can also contact The Children's Trust Helpline at 211 for a list of health centers offering vaccines for children.

If your child has already received the required school-age vaccine, it is essential that you take the updated **Florida Certificate of Immunization DH-680** form to your child's school.

Asimismo, puede comunicarse con la línea de asistencia de *The Children's Trust* al 211 o donde tendrá acceso a un listado de centros de salud que ofrecen vacunas para niños.

Si su hijo(a) ya recibió la vacuna requerida para niños en edad escolar, es esencial que lleve el formulario **DH-680**, Certificación de Inmunización de Florida (**Florida Certificate of Immunization DH-680**) actualizado a la escuela de su hijo(a).
